<u>CPYC Temporary Overnight Slip Rental and Transient Mooring Program</u>

The following is a reminder of the Club's temporary slip rental and transient mooring program for this season. Please note that all slip and mooring rentals must be pre-authorized and approved, in advance, by phone or via e-mail, by the Club Wharfinger. We have limited temporary overnight slips and demand has been increasing, so please call and reserve well ahead of your planned dates.

Eligibility: CPYC Regular member (boat owning)

CPYC Social member (boat owning)

Visiting Yachtsman from another yacht club

Guest of CPYC member or Wharfinger

Boat Size and Type: No less than 17 ft. Power or Sail w/ motor for Slip, No greater than 46ft for Slip or Mooring

<u>Time Period</u>: Marina Opening Day thru Marina Closure Day (Oct)

Authorization: In advance, by reservation/permission only thru CPYC Wharfinger

<u>Reservation Period</u>: Slip-Per Diem with maximum of 7 total/consecutive days, no earlier that 30 days in advance Mooring-Per Diem with 30 day maximum period but extendable with Wharfinger approval

<u>Cost:</u> Slip: \$30/night for CPYC regular members*, <u>members of reciprocating clubs, \$2.50/ft. with 30ft minimum</u> <u>for non-CPYC members/guests</u>, <u>non-reciprocating clubs</u>, <u>and CPYC social members</u>. Mooring: \$15 per night for CPYC all <u>regular members</u>, \$45 per night for all for non-CPYC members/guests, non-reciprocating clubs and CPYC social members

Payment: Prior to occupancy, by cash or credit card at Pilot House/Westerly Bar (no chits)

<u>Cancellation</u>: 24 hr. prior notice to occupancy start date-no charge, one-night charge, otherwise. Wharfinger must be contacted by phone or via e-mail to properly cancel a reservation

No Show: Renter will be liable for the full amount due for the entire reserved rental period, unless properly canceled, in advance, as cited above.

<u>Designated Slips</u>: T2, T3, T4, T5, & T7 (see Marina Float Plan posted to PH bulletin board and website)

Designated Moorings: one of two CPYC Owned Moorings or Permitted member's mooring

Unauthorized Tie -Up: Daily Rental Rate plus \$100 fine per night

Water and Electric: As available, with no charge, renter must have proper power cables and hoses

<u>Insurance</u>: Renter must have adequate liability and property damage insurance coverage via watercraft policy or properly endorsed homeowner's policy

*\$30/night is for CPYC mooring occupants that have paid current year marine facilities and dredge assessment
